Candidates will not be allowed to enter the venue after 11 AM. Late/delayed/incomplete applications will be summarily rejected without any intimation; only eligible candidates will be allowed for interview. Canvassing in any form will be a disqualification. Candidates are required to mention their complete address with Pin Code, Mobile number and E-mail ID.

Terms & Conditions: -

1. Qualification & experience should be in relevant discipline/field from an Institution of repute. Experience should have been gained after acquiring the minimum essential qualification.
2. Mere fulfilling the essential qualification does not guarantee selection.
